This Memorandum of Understanding signed on this 17 day of February 2021.

BETWEEN

SISHU KALYAN SAMITI having its single functionary unit namely S.C.B. Medical Public School at: S.C.B. Medical College Campus, Cuttack-753007, Dist: Cuttack, a Society, registered under Societies Registration Act, 1860, bearing Regd. No.6790/433 of 1972-1973 dated 04.12.1972 represented through its authorized signatory, Shri Rabindra Nath Mohanty, Secretary, aged about 76 years, S/o Late Kanhu Charan Mohanty, by caste : Karan, by profession : Social Service (hereinafter called as "The Samiti ") of the one part

AND

D.A.V. COLLEGE TRUST & MANAGEMENT SOCIETY, a Society registered under the Societies Registration Act, 1860 having its registered office at "Chitragupta Road, New Delhi-110055, represented through its General Secretary, Shri Ajay Suri aged about 70, S/o Late S.L. Suri hereinafter referred to as " The Society") of the other part.

WHEREAS the Samiti is running a single functionary unit namely, "S.C.B. Medical Public School, Cuttack" affiliated to Council for the Indian School Certificate Examinations(CISCE), New Delhi and desires to hand over the management of the School to the Society along with the existing land and building, assets and liabilities on as is where is basis to run the "DAV S.C.B. Medical Public School, Cuttack" under the direct control of DAV College Trust & Management Society, New Delhi in self financing scheme in order to enrich the quality of education being imparted in the school functioning under the control of the Samiti.

WHEREAS the Samiti is running only one co-educational school from KG to Class X in a building having around 39 Class rooms, One Library, One play ground, Two Computer Labs, One Home Sc. Lab; One NCC/Scout & Guides room; Three Science Labs, one Staff Room, Principal's Room and 14 Toilets etc over a piece of land measuring Ac1.800 dec, under Tahasil: Sadar Cuttack, Mouza: Cuttack Town Unit No.20, PS: Mangalabag, Khata No. 132, Plot No. 228/820, which is being managed by SCB Medical Public School, the only functionary unit of the Samiti and the Samiti desires to handover the management of the said school to the Society from the academic session 2021-2022.

WHEREAS, S.C.B. Medical Public School, the only functionary unit of the Samiti is the possessor of the land described in the schedule and building. The said land and building are in possession of "The Secretary, S.C.B. Medical Public School, Cuttack" vide Order No.805 dated 09.03.2006 of the Collector, Cuttack. The School has been possessing the said land and building without any dispute and the schedule land and building are free from all encumbrances. The Managing Committee of the school & the Samiti wants to hand over said land and building as well as the Management of the S.C.B. Medical Public School, Cuttack to the DAV Society completely.

AND WEREAS it has been further mutually agreed to reduce in writing the terms and conditions mutually agreed upon, between the Samiti and the Society for administering the school and in furtherance of the same this Memorandum of Understanding being made through the Secretary of SCB Medical Public School, the only functionary unit of the Samiti and the General Secretary, DAV College Trust & Management Society, New Delhi for and on behalf of the Society is being executed.



NOW THEREFORE, for good and valuable consideration, the sufficiency of which is hereby acknowledged, the Parties i.e. both the Samiti and the Society hereby mutually agree to the following terms and conditions.

Now these presents witnesseth as under:

1. That under the terms and conditions, hereinafter set forth the Society hereby agrees to run the composite Co-educational Secondary School in English Medium from Class LKG leading to Class X on Public School lines to be up-graded up to Senior Secondary level. The school shall be got affiliated by the D.A.V. College Managing Committee (D.A.V.C.M.C.) with the Central Board of Secondary Education, Delhi.
2. That for getting the school affiliated with the Central Board of Secondary Education, New Delhi, the **Samiti** shall co-operate in complying the requirements of affiliating agency and provide a resolution / certificate to the effect that the land, building and management of the school has been handed over by the **Samiti** to the **Society** i.e. DAV College Trust & Management Society, New Delhi to run "**DAV S.C.B. Medical Public School, Cuttack**". Further, the School shall take necessary steps for informing the **Council for the Indian School Certificate Examinations (CISCE)**, New Delhi for such transfer of the Management of S.C.B. Medical Public School, Cuttack.
3. That the name of the school shall be "**DAV S.C.B. Medical Public School, Cuttack**", Plot No. 228/820, Mangalabag, Cuttack and shall be directly governed and controlled by the D.A.V. College Managing Committee, New Delhi which is an administrative branch of the **Society**. The proposed "**DAV S.C.B. Medical Public School, Cuttack**" shall run on self-sustainable mode by the DAVCMC, New Delhi.
4. That the D.A.V. College Managing Committee shall constitute the School Managing Committee (S.M.C.) for efficient running of the school. The term of the Committee shall be three years.
5. That the Society, i.e. DAV College Managing Committee shall appoint the Head of the school whose selection shall be done at the **Head quarter of the Society** in New Delhi. The existing trained teachers and non teaching members of staff under regular establishment will be recruited as per the DAVCMC norms and shall be given fresh appointment letters. All the employees will be entitled to all terminal benefits like Gratuity, EPF, Pension, Leave Encashment, EDLI etc from the date of fresh appointment issued by DAV Society.
